Processing Delays:

- D1 Awaiting probation investigation/report
- D2 Awaiting special evaluation
- D3 Awaiting court papers before moving child
- D4 Law Guardian/Prosecutor delay
- D5 Waiting for other relative resource
- D6 Other Processing delay

Placement Availability:

- P1 No placement available in child's county/geographic area
- P2 No Placement available for child's needs
- P3 No agency will accept child
- P4 Placement found, awaiting opening

P5 Judge will not approve placement that was found

- T1 Need to address child's medical problems for health/safety
