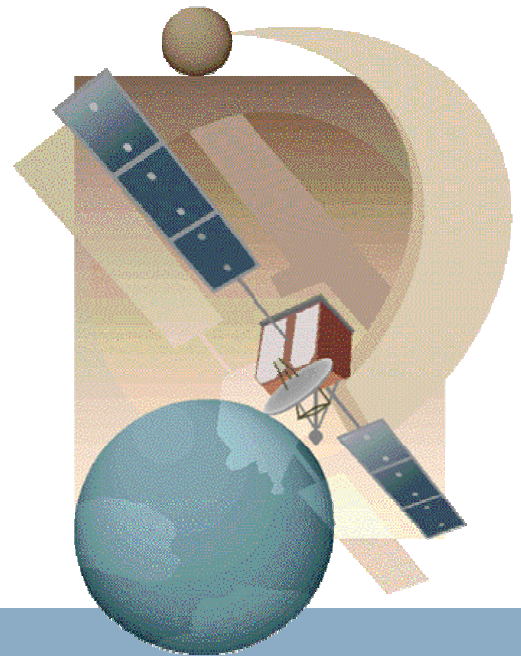

**Description:** The new Permanency Bill has been signed into law as Chapter 3 of the Laws of 2005. As the full implementation on December 21, 2005 approaches, many districts, agencies and Family Courts have begun the process of preparing new procedures and practices to integrate the provisions of the law into their daily operations and practices. The NYS Office of Children and Family Services (OCFS) has been working with the New York State Office of Court Administration and New York City's Administration for Children's Services as well as districts and voluntary agencies statewide to support a smooth transition to the new requirements.

The October 20th teleconference will provide up to date information on :

- OCFS, ACS and OCA implementation preparation activities
- Guidance on working with Family Court to calendar the hearings.
- The relationship between the content and purpose of the FASP and the Permanency Hearing Report
- Timeline for the FASP cycle, Service Plan Reviews, the Permanency Hearing Report and the Permanency Hearing
- An update on the development of the new Permanency Hearing Report
- Possible impacts of the report on district and agency business processes and case practices
- How the Law can support current efforts to improve practice and outcome achievement
- Responses to some FAQs
